- Experience of analyzing experimental data acquired using spectroscopic instruments.
- Experience in preparing technical documents.

Nature of Work:

- Design and development of calibration source for spectroscopic diagnostic in X-ray range;
- Theoretical estimation of spectral line intensities of X-ray spectral line
- Planning and execution of experiments on the tokamak and analysis of experimental data;
- Preparation of technical documents.

Tenure of Appointment: The above mentioned post is temporary. Initially the appointment is for 01 (one) year. The tenure may be extended, for 01 (one) more year or a part thereof depending on the requirement, or co-terminated with the project.

Selection Process: The selection will be solely based on the performance in the walk-in-interview.

Emoluments: The RA shall be paid monthly fellowship as per the prevailing DAE's OM No. 10/1(21)/2014/Fellowship/R&D-II/14812 dated November 9, 2023 or as recommended by DAE from time to time. Other terms & conditions will also be as per the said DAE's OM. IPR CHSS medical facility coverage will be for self only and for this facility necessary deduction will be made every month from the salary as per IPR CHSS rules.

- ii) Post-Ph.D. Research experience as evidenced from the quality of the publications and/or products/ processes designed and developed and
- iii) Performance in the selection interview
