All communications are to be addressed to the undersigned only. In case, due date happens to be holiday, the tender will be accepted and opened on the next working day.

Quoting of Price (s): Price quoted should be in Indian Rupees without GST, collection from IPR, Bhat / Gandhinagar Campus at site on **AS IS WHERE IS AND AS IS WHAT IS** basis.

GST% and HSN Code will be firm and fixed as indicated in the Price Bid Section.

If Price bid is not quoted in PRICE BID as provided in Tender document, IPR, Bhat / Gandhinagar will Reject Bid along with forfeiting Earnest Money Deposit Cum Security Deposit.

CANCELLATION OF TENDER:

Not with standing anything specified in this tender document, Seller / IPR, Bhat / Gandhinagar in his sole discretion, unconditionally and without having to assign any reasons, reserves the rights:

- a) To accept OR reject highest tender or any other tender or all the tenders.
- b) To accept any tender in full or in part.
- c) To reject the tender offer not confirming to the tenders terms.

अन्भाग 4 - नियम और शर्तें / SECTION 4 - TERMS AND CONDITIONS

- 1. For the offered scrap items, Vendor can participate with applicable EMD cum SD which is to be submitted alongwith offers.
- 2. The Bidders/Vendors workmen shall have to abide by the rules regulation including safety & security regulation of the relevant statutory Acts. Entry inside the works should only be against Gate pass for the men and equipment for which vendor will have to apply well in advance before lifting commences.
- 3. The Buyer will employ his own labor and means; at his own cost and risk for removal/collection/shifting of scrap as per schedules and payment of wages/compensation to the laborers will be the sole responsibility of the buyer. The purchaser shall ensure that his workmen do not loiter around within the stores area of the institute areas. They shall not touch any material except those materials shown to them. If any of his workmen is even found violating these restrictions, the Buyer shall be responsible for making goods the loss to the owners on which their decision shall be final and binding.
- 4. The items for disposal are offered purely on 'AS IS WHERE IS AND AS IS WHAT IS' basis only.
- 5. The IPR reserve the right to black-list, debar any bidder/buyer due to any act of omission or commission or fraudulent acts indulged or caused to be indulged by such bidder/buyer in the course of bidding process and/or in the execution or performance of any of the contracts which may be awarded to the bidder/buyer.

Award of Contract:

IPR will drive the H1 based on the offered rates.

Payment Terms, Scrap collection and other terms and conditions

- o IPR, Bhat / Gandhinagar will select H1 vendor for disposal of scrap and issue sale order and quoted rate will remain unchanged.
- If the vendor refuses to accept the sale order from the IPR, IPR shall forfeit the EMD Cum SD amount of the vendor.
- o The vendor will be required to submit acceptance of the sale order.
- Vendor has to deposit advance amount of Scrap sale invoice and applicable GST as well TCS before lifting of the sold material.
- Vendor has to lift the scrap material within 15 days from the date of Sale Order and should clean the site. You should make own arrangement for weighment, Loading, collection and transportation at your own cost.
- Payment for Sold Scrap alongwith applicable GST and TCS is to be made through RTGS / NEFT. Bank details will be provided in the Sale Order to the successful bidder.

Earnest Money Deposit Cum Security Deposit:

EMD of unsuccessful bidders will be returned within 30 days after the award of the contract. For successful bidder, EMD will be converted into the Security Deposit.

EMD of a tenderer will be forfeited, if the tenderer withdraws or amends its tender or derogates from the tender in any respect within the period of validity of its tender. F

Penalty:

If the lifting of the material with cleaning site is not done within 15 days from the date of Sale Order, Buyer have to pay Ground/Room rent charges for delay. Ground/Room rent charges shall be 0.50% of the Sale Order Amount per week shall be charged upto 15 days after 15 days 1% shall be charged up to 30 days. Any loss incurred will be recovered from the payment prejudice to any action the Director may take.

Any kind of relaxation in penalty with due request of genuine explanations will subject to IPR committee recommendation only.

Lifting of the Scrap:

The Contractor will be required to complete the lifting formalities strictly within 15 days from the date of Sale Order and clear the site.

Damages:

The Purchaser shall make good all losses or damages which is caused to or may be caused to any property of the seller or to any other person by any act or omission or default of the purchaser or his agent, person or servants of the Purchaser while in the premises of the seller as may be intimated by the seller in writing within 30 days of noticing the damages / losses.

Safety and Security:

• The Contractor will have to strictly adhered to the Rules and Regulations of the Safety and Security of the Institute

Force Majeure:

If either party is prevented, hindered or delayed from or in performing any of its obligations under the contract by an event of force majeure, then it shall notify the other in writing of the occurrence of such event and the circumstances thereof within fourteen days after the occurrence of such event. A party shall give notice to the other party when it ceases to be affected by the force majeure. Failure to notify the seller about occurrence of such event within the time frame specified, the contractor shall have no right to claim.

All disputes arising out of this tender shall have the Jurisdiction of Gandhinagar only.
